- 1. <u>Parties.</u> This Amendment is made and entered into by and between the Wyoming Game and Fish Commission (Commission), by and through the Wyoming Game and Fish Department (Agency), whose address is: 5400 Bishop Boulevard, Cheyenne, WY 82006, and WYOMING WILD SHEEP FOUNDATION (Grantee), whose address is: Post Office Box 583, Dubois, WY 82513.
- 2. <u>Purpose of Amendment.</u> This Amendment shall constitute the first amendment to the Grant Agreement (Agreement) between the Agency and the Grantee. The purpose of this Amendment is to extend the Performance Period of the Agreement through May 31, 2021.

<u>The Original Grant Agreement</u>, dated May 11, 2020, required the Grantee to hire Dr. Jessica Western from the Ruckelshaus Institute at the University of Wyoming to design and facilitate a community collaborative process on Teton bighorn sheep and recreation in Jackson and secure a venue and supplies for public collaborative meetings for a total Agreement amount of twenty-three thousand, five hundred forty-seven dollars and fifty cents (\$23,547.50) with an expiration date of December 31, 2020.

3. <u>Term of the Amendment.</u> This Amendment shall commence upon the date the last required signature is affixed hereto (Effective Date), and shall remain in full force and effect through the term of the Agreement, as amended, unless terminated at an earlier date pursuant to the provisions of the Agreement, or pursuant to federal or state statute, rule, or regulation.

#### 4. <u>Amendments.</u>

**A.** The second sentence of Section 3 of the original Grant Agreement is hereby amended to read as follows:

Amendment One to the Grant Agreement between Wyoming Game and Fish Commission and WYOMING WILD SHEEP FOUNDATION Page I of3 "The Performance Period of the Agreement is from the Effective Date through May 31, 2021."

- 5. <u>Amended Responsibilities of the Grantee.</u> The responsibilities of the Grantee have not changed.
- 6. <u>Amended Responsibilities of the Agency.</u> The responsibilities of the Agency have not changed.
- 7. Special Provisions.
  - A. Same Terms and Conditions. With the exception of items explicitly delineated in this Amendment, all terms and conditions of the original Grant Agreement, and any previous amendments, between the Agency and the Grantee, including but not limited to sovereign immunity, shall remain unchanged and in full force and effect.
  - **B. Counterparts.** This Amendment may be executed in counterparts. Each counterpart, when executed and delivered, shall be deemed an original and all counterparts together shall constitute one and the same Amendment. Delivery by the Grantee of an originally signed counterpart of this Amendment by facsimile or PDF shall be followed up immediately by delivery of the originally signed counterpart to the Agency.

## 8. <u>General Provisions.</u>

A. Entirety of Agreement. The original Grant Agreement, consisting of ten (10) pages; and this Amendment One, consisting of three (3) pages, represent the entire and integrated agreement between the parties and supersede all prior negotiations, representations, and agreements, whether written or oral.
