- Dean spent most of his time getting used to finances, selling raffle tickets and preparing the new Zeffy raffle site.
- Montana Fencing Project We are waiting on paperwork before proceeding with a workday.
- John Harris and Katie have submitted the nomination of Jim Collins for the WSF Grassroots award.
- Marketing Position In exchange for the chapter paying travel expenses to Sheep Week, Jaden will continue the Red Stag raffle publicity.
- Sheep Week Booth- JW is in charge and plans are moving forward. Tera to work on shirts.
- SRI:13 more wild sheep have been removed in the Pedros. The board disagrees with the Game and Fish policy of lethal removal even when no contact with domestic sheep has occurred. We will prepare a press campaign to bring this to the public's attention. Jaden, Matt and Katie will take charge of the planning. Bralli will survey the area for small domestic flocks. We will present innovative solutions to the G&F and possibly fund collars.
- The RamPage is at the printer and will be in homes about October 20.
- Raffles. The committee continues to meet and has several potential new raffles coming.
- SRI. A small group of the Interaction Working Group met and discussed the proposed federal language during a meeting in Rawlins today. The goal is to finalize the language by Nov and get a letter to the Federal delegations this year.
- Seminoe Pump Storage. A draft EIS has been released, and the comment period is open through January 2026. Our chapter has submitted comments.
- Veterans HA 17 hunt. Our recipient was successful. There will be a story in the RamPage and we hope to have him and the license donor and our outfitter present at the Winter Meeting.
