- Call to Order: President Clifford called the meeting to order at 7 PM

- Previous Meeting Minutes
 - After reviewing the previous meeting minutes, the board approved them for posting with a motion from John Harris and second by Scott Butler.
- Treasurer Report:
 - After a review of our finances and the checks written report, the treasurer's report was approved on a motion from John Harris and a second from Zach McDermott.

- Pedros 13 more wild sheep have been removed in the Pedros. The board disagrees with the Game and Fish policy of lethal removal even when no contact with domestic sheep has occurred. We will prepare a press campaign to bring this to the public's attention. Jaden, Matt and Katie will take charge of the planning. We have sent a letter to the G&F detailing our objections and proposing solutions.
- Eastern Chapter Predator Hunt Nothing new to report.
- Board Self Evaluation. After Sheep Week, we will publish a board of director's self-evaluation survey to allow us to understand how we are doing as a board and what areas need work. Dean and Bralli have developed the survey
